Erklärung zur REACH-Verordnung 1907/2006/EG **Declaration in regard to the REACH Regulation 1907/2006/EC**

Die EG-Verordnung **REACH** 1907/2006/EG (**R**egistration, **E**valuation, **A**uthorisation and **R**estriction of **C**hemicals) bezieht sich auf die Registrierungspflicht chemischer Stoffe.

*The EU regulation **REACH** 1907/2006/EC (**R**egistration, **E**valuation, **A**uthorisation and **R**estriction of **C**hemicals) refers to the registration of chemical substances.*

Die Glen Dimplex Deutschland GmbH (GDD) produziert oder importiert (von außerhalb der EU) keine im Sinne von REACH registrierungspflichtigen Stoffe und Zubereitungen (nachfolgend Stoffe genannt, wobei immer auch Zubereitungen umfasst sind) in einer Menge von zumindest einer Tonne pro Jahr. Außerdem verkauft GDD keine Stoffe als Wiederverkäufer in einer Menge von zumindest einer Tonne pro Jahr.

The Glen Dimplex Deutschland GmbH (GDD) does not produce or import (from outside of the EU) substances and preparations subject to registration (called "substances" in the following, whereas preparations are always considered to be comprised as well) in the sense of REACH in an amount above at least one ton per year. Furthermore, GDD sells no substances as a reseller in an amount above at least one ton per year.

GDD ist somit ausschließlich als nachgeschalteter Anwender tätig und verwendet registrierungspflichtige Stoffe ausschließlich gemäß den Vorgaben des jeweiligen Lieferanten. Somit unterliegt GDD nicht der Verpflichtung, Stoffe im Rahmen von REACH registrieren zu lassen oder einen Stoffsicherheitsbericht, ein Sicherheitsdatenblatt oder ein Expositionsszenarium für diesen Stoff zu erstellen.

Therefore, GDD is only acting as a downstream user and uses substances subject to registration only in the way intended of the respective supplier. Therefore, GDD is not obliged to register substances according to REACH or to provide a chemical safety report, a safety data sheet or an exposure scenario for that substance.

Weder die Produkte von GDD, noch deren Verpackungen enthalten einen der besorgniserregenden Stoffe, SVHCs (**S**ubstances of **V**ery **H**igh **C**oncern) nach der Kandidatenliste der Europäischen Chemikalienagentur ECHA (zuletzt aktualisiert am 20.6.2013) oder nach Anhang XIV der REACH-Verordnung gelisteten Stoffe mit einem Massenanteil von > 0,1 %.

Neither the products of GDD nor their packaging contain SVHCs (Substances of Very High Concern) listed in the candidate list of the European Chemical Agency ECHA (last updated on the 20th of June, 2013) or listed in Appendix XIV of the REACH Regulation with a mass amount larger than 0.1 %.

Bei neuen Lieferantenartikeln prüft GDD bei den entsprechenden Lieferanten nach, ob in den gelieferten Artikeln SVHCs enthalten sind.

For new supplier's articles, GDD checks whether that article contains SVHCs.

GDD hält die Vorgaben des Anhang XVII der REACH-Verordnung betreffend Beschränkungen der Herstellung, des Inverkehrbringens und der Verwendung bestimmter gefährlicher Stoffe ein. Bei neuen Lieferantenartikeln prüft GDD nach, ob die Vorgaben hinsichtlich Anhang XVII eingehalten werden.

GDD complies with the requirements of Appendix XVII of the REACH-Regulation in regard to restrictions of manufacturing, placing on the market or use of certain substances. For new supplier's articles, GDD checks whether that article contains substances listed in Appendix XVII.

Zusätzlich wird das Einhalten der Vorgaben von REACH explizit in den Geschäftsbedingungen von GDD gefordert.

Additionally, compliance with REACH is explicitly demanded in the order conditions of GDD.
