## **INFORMATION FOR OUR CUSTOMERS – concerning Corning Optical Communications Status with respect to the EU REACH Regulation**

Corning Optical Communications considers the protection of the environment, natural resources and health as one of its most important business tasks. Corning Optical Communications therefore devotes significant efforts and resources to the development of clean and safe products and processes and therefore concurs with the aim of the European Union **Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) Regulation (1907/2006/EC)**.

Most products made by Corning Optical Communications do not contain substances that are intended to be released under normal and foreseeable circumstances and are therefore not concerned by Article 7.1 of the REACH Regulation.

However, some of our products may be concerned by Article 7.2 of the REACH Regulation, which requires notification of substances in products, if these are of high concern, exceed 0.1% (w/w) and exceed 1 ton/year per importer or producer. Article 33.1 of the REACH Regulation imposes certain obligations on importers and producers of products to inform their customers about substances of high concern (such as carcinogens, mutagens and reprotoxic substances if category 1 and 2,

Persistent Bioaccumulative and Toxic (PBT) substances, and very Persistent very Bioaccumulative (vPvB) substances) in the product at concentrations greater than 0.1% (w/w).

The first candidate list of substances of high concern was published on the 28<sup>th</sup> of October 2008 and latest updated on the **25<sup>th</sup> of June 2020**. Corning Optical Communications has analysed its product and has come to the conclusion that the products with numbers:
