

REACH-Regulation, No 1907/2006 EC Information to Substances of Very High Concern (SVHC's)

According to article 59 (1, 10) of the Regulation (EC) No 1907/2006 (REACH), an updated candidate list was published. (Last updated on 27.06.2024 – 241 SVHC's)

According to our evaluations and confirmations of our suppliers our articles and their packaging's do not contain any of these substances of the candidate list (27.06.2024 – 241 SVHC's) in concentrations above 0.1 % weight by weight.

Exclusion to this are the following articles which contain the following substance in the candidate list in concentrations above 0.1% by mass:
